Prospective Member:

Thank you for your interest in the Fraternal Order of Police Willamette Valley Lodge #7. To apply for membership, complete the attached application and include a check covering the Initiation Fee and the start-up cost for the FOP Legal Plan (if chosen). A current Lodge member must be listed as a sponsor on the application form.

A new member Initiation Fee of **\$20.00** must be included with the application along with the cost to start-up the legal plan chosen by the member; **\$30.00** for **Plan A** or **\$60.00** for **Plan B**. All monies are refundable pending the review of the application and acceptance into the Lodge.

Members pay dues in the amount of \$5.00 per month (an annual total of **\$60.00** per year). Most members choose to participate in the FOP Legal Plan. If you choose one of the Legal Defense Plans listed below, the Lodge will collect dues monthly (\$10.00 per month for Plan A or \$25.00 per month for Plan B). If you choose not to participate in one of the Legal Defense Plans, the full \$60.00 Annual Dues along with the \$20.00 Initiation Fee is collected with the completed application form.

You can find the detailed description for each legal plan on the FOP Grand Lodge Home Page under Programs and then Legal Defense Plan. Disregard the prices on the web page. Our Lodge receives a Group Discount and we collect monthly Lodge Dues with the monthly installments for the legal plan chosen by the member. The Lodge pays semi-annually for the legal plan to the plan administrator for all members who participate in the FOP Legal Plan.

Legal Plan Costs and Monthly Dues Payments

Plan #A - (Criminal, Civil) = \$5.00 Month

**Good for Union Members

- Your monthly dues payment to the Lodge starting the following month is **\$10.00** (\$5.00 Lodge Dues + \$5.00 Legal Plan A)

Plan #B - (Administrative, Criminal, Civil) = \$20.00 Month

**Best for Administrators and other Exempt Officers

- Your monthly dues payment to the Lodge starting the following month is **\$25.00** (\$5.00 Lodge Dues + \$20.00 Legal Plan B)

Once the initiation fee and any legal plan start-up costs are collected and your application is approved, your name will be entered into the National Registry and on to the Oregon State FOP Lodge roster. We will then be able to sign you up for the Legal Defense Plan you chose through the plan administrator using the start-up cost money collected.

To summarize, complete the attached application and include a check for one of the following amounts:

- Plan A- **\$50.00** dues then paid monthly (\$10.00)
- Plan B- **\$80.00** dues then paid monthly (\$25.00)
- Membership Only- **\$80.00** no monthly dues (\$60.00 annually)
